



U.S.T.A. LEAGUE PLAY RULES

These rules and regulations are set forth by Anthem Country Club.

1. No more than two courts per team may be used for team practices and only 5 courts total can be used on Saturdays for league matches between 11:00 a.m. - 6:00 p.m. For a nominal fee a team may schedule a clinic with an Anthem Country Club Tennis Pro.
2. Each team is allowed one practice per week. Two courts may be used for team practices lasting no more than 90 minutes. At least one Anthem member must be present at all team practices.
3. A roster of the team's players as well as their phone numbers must be provided to the Anthem Tennis Director and the roster must be approved by the Anthem Tennis Director prior to the start of the season.
4. A list of team home matches must be provided to the Anthem Tennis Director.
5. All non-member guests must be checked in at the Monitors desk anytime they are not playing in a league match or attending an official team practice.
6. We ask that any and all trash be deposited in the appropriate receptacles.
7. Tennis court hours of operation are from 6 a.m. until 10 p.m.
8. The U.S.T.A. rules of tennis shall apply at all times, except when in conflict with the Anthem Country Club league play rules or with any of the rules herein.
9. No food or beverage items (other than water in plastic containers) are allowed on the tennis courts.
10. Appropriate tennis attire (as determined by Anthem Country Club) must be worn at all times when using the tennis courts. Shirts are required at all times.

11. Black soled and/or running shoes will not be permitted on the tennis courts.
12. All injuries and related accidents must be reported to Anthem Country Club immediately.
13. Proper tennis etiquette should be observed at all times. Excessive noise, racquet throwing, or profanity will not be permitted at any time.
14. All players and/or teams must register at the Athletic Club before commencing play.
15. At the end of the playing period, players must promptly relinquish their court to the next players.
16. Teams must include at least two Anthem Country Club members and one of the members must act as team captain.
17. Non-Anthem Country Club team players will pay \$105.00 per person per season to play on an Anthem team. Team captains are responsible for collecting all fees and turning them in to the Anthem Tennis Director prior to the start of the season.
18. All teams and/or players must register at the Athletic Club and arrange court time before commencing play. Failure to do so may result in the unavailability of a court for your play.
19. Club tournaments, clinics, lessons, and league matches have preference on the courts.
20. If a team signs up for weekly clinics with the Club's tennis professional, the fee for the entire season must be paid in advance.
21. Non-Anthem Country Club members are permitted to use the tennis facility only. All Club amenities are for member use only.
